The buyer agrees to obtain from the seller an Olde English Bulldogge Puppy.

TERMS:

This dog is not being sold under co-ownership terms. Payment in full must be made prior to you taking ownership of the dog; payment is in cash, money order, cashiers check, wire transfer or bank transfer.

We will not sell to pet store(s), puppy mill(s) or brokers. If unable to care for or keep your puppy, contact us first for options or returning your puppy.

Border's Bullies ONE-YEAR GUARANTEE:

1. The purchaser must have the puppy examined by a licensed veterinarian within two (2) business days of arrival.
2. Border's Bullies must be informed immediately of the examination results by e-mail or fax. *Failure of this will result in the cancellation of this guarantee.*
3. If the examination indicates that at the time of sale, such animal was unfit for purchase due to illness, disease or congenital disorder, you may return the puppy to us for an exchange of equivalent value.
4. Border's Bullies guarantees the puppy against fatal viruses for 72 hours. These include, distemper and Parvo and Corona. It does NOT include Coccidia and Kennel Cough which is common in pups that are shipped and usually caused by bacteria. Kennel cough is self limiting and like the common cold, it must run its course. Full recovery is expected and Kennel cough on its own is not life threatening.
5. This puppy is guaranteed until one (1) year of age against fatal and life altering congenital and genetic disease which adversely affects the health of the animal. This includes: Severe Hip dysplasia - which hampers a dog's movement and natural gait

and requires surgery to correct, kidney, heart, pancreas, spine and liver problems of a severe life threatening or altering nature. If the dog dies within this one (1) year time frame, purchaser will pay to have it autopsied to ascertain reason. If reason is genetic or congenital, Border's Bullies will replace the puppy.

6. Border's Bullies must be notified of the problem within two (2) business days of the licensed veterinarian's determination and have two (2) reports from two (2) different veterinarians stating the same problem and Border's Bullies will provide a replacement puppy of equivalent value with no cash return. Purchaser is responsible for the transportation cost of the replacement puppy.
7. Border's Bullies will not be responsible for veterinarian fees or costs. Purchaser is aware that owning a puppy means trips to the veterinarian and understands that he/she will be responsible for all payments.
8. There is no guarantee or warranty that the purchaser will be able to show or breed the puppy regardless of show or breeding potentials.
9. This guarantee covers the original purchaser and puppy and is not transferable to another owner.
10. Purchaser will keep the puppy current on all vet care including shots, dewormings and heart worm treatment. Purchaser agrees to feed the puppy with premium dog food and not allow the puppy to become obese. Border's Bullies advises that it's a good idea to keep the new puppy separate from other dogs in the house and out until the veterinarian has given it a clean bill of health.
11. In the event of any litigation, in connection with this Guarantee, Border's Bullies will be paid reasonable attorney fees by the purchaser. This contract is valid only for original purchaser and puppy, it is not transferable. Registration papers for all registered puppies will be sent by regular mail. If the papers are lost, the purchaser is responsible for the cost of obtaining new papers. However, we will assist you by providing a copy of these papers.

I, the purchaser of a puppy from Border's Bullies, hereby acknowledge that I have received a copy of this document. Further, I accept the terms and conditions of the guarantee for congenital or hereditary disorders printed in this document, and I waive and relinquish any other rights that I might otherwise have in the event of such occurrence. The purchaser acknowledges that he or she has read, understands and agrees to the terms of this document. **No cash refunds.**
